I SUBMIT THIS INDEPENDENT INTERPRETATION WITHOUT POLITICAL INTERFERENCE TO DEMONSTRATE MY QUALIFICATIONS FOR EMPLOYMENT IN THE UNITED STATES FEDERAL BUREAU OF INVESTIGATION.**

**1. PRESIDENT GEORGE W. BUSH AND VICE PRESIDENT RICHARD B. CHENEY EMPLOYED TOM RIDGE TO COVER-UP THE FRAUD AT THE DEPARTMENT OF TRANSPORTATION, THE NATIONAL TRANSPORTATION SAFETY BOARD, AND THE FEDERAL AVIATION ADMINISTRATION UNDER THE REORGANIZATION PLAN OF THE TRANSPORTATION SECURITY AGENCY.**
